The Administrator has been pleased, under the provisions of section ninety-nine of the Local Government Ordinance, 1939, to approve the By-laws set forth in the Schedule hereto.

SCHEDULE

TRANSVAAL BOARD FOR THE DEVELOPMENT OF PERI-URBAN AREAS; BY-LAWS RELATING TO DOGS

1. For the purpose of these By-laws unless the contents indicated otherwise—

“Board” shall mean the Transvaal Board for the development of Peri-Urban Areas constituted under Ordinance No 20 of 1943 (Transvaal).

“dog shall include any dog or bitch;

“local area committee” shall mean a local area committee established under the provisions of subsection (1) of section twenty-one of Ordinance No of 1943 (Transvaal) or any amendment thereof;

“public place” shall include any road, street, thoroughfare, bridge, overhead bridge, subway, pavement, open space, garden, park and enclosed space vested in the Board under section sixty-three of the Local Government Ordinance, 1939;

“street” shall include any street, road or thoroughfare shown on the general plan of a township or in respect of which the public have acquired ... prescriptive or other right of way.

- (*2) 2 (a) These By-laws shall apply only within the area of jurisdiction of the local area committees mentioned in the Schedule hereto

- (b) No person shall keep on any premises within the area of a local area committee more dogs than the number prescribed in the Schedule hereto.
- 3. No person shall keep any dog, which creates a disturbance or a nuisance to the neighbors by constant or excessive barking, howling whining.
- 4. No person shall permit any dog, which is dangerous or vicious or suffering from any contagious or infectious disease, or bitch on heat to at large in any public place.
- 5. (a) The board may through its authorized officials destroy or cause the destruction of any dog, which evidently is ownerless or unclaimed or diseased and at large (*1) in/or any public place and may dispose of the dead body in any manner it may deem fit.

(b) In no circumstances shall the Board be liable for the payment of any compensation or damages to any person as a result of the destruction of a dog in terms of the provisions of this section.
- 6. Any person contravening any of these By-laws shall be guilty of an offence and liable on conviction, to a fine not exceeding fifty (50) or in default of payment to imprisonment with or without hard labour for a period not exceeding three (3) months.
