

**MUNICIPAL CODE:**  
City of Ekurhuleni Metropolitan Municipality

The By-Laws adopted since 6 December 2000 by the City of Ekurhuleni Metropolitan Municipality as well as the By-Laws of the disestablished municipalities in place prior to 6 December 2000 and are still in force, are listed in the Municipal Code. The By-Laws of the disestablished municipalities will eventually be repealed or replaced by uniform City Ekurhuleni Metropolitan Municipality By-Laws.

The By-Laws contained in the Municipal Code, are only amended and/or updated once passed by Council and promulgated in terms of Sections 11, 12 and 13 of the Local Government: Municipal Systems Act, read with Section 7 of the Rationalisation of Local Government Affairs Act.

The Municipal Code has been compiled and is updated by the Department Corporate Legal Services.
