



## CITY OF EKURHULENI CONTRACTOR DEVELOPMENT PROGRAMME

The City of Ekurhuleni hereby invites contractors registered on CIDB Grades 1 to 5 to apply for admission into the 2025 Ekurhuleni Contractor Development Programme.

The CoE Contractor Development Programme is a three (3) years programme intended to admit a maximum of 50 contractors around the CoE into a contractor development programme that shall be offered in three distinct categories, namely:

- i. Emerging Contractor Development Programme aimed at CIDB Grades 1 and 2 contractors.
- ii. Contractor Development Incubator Programme aimed at CIDB Grades 3 and 4 contractors.
- iii. Contractor Improvement Programme aimed at CIDB Grade 5 contractors.

The programme's envisaged developmental outcomes will be achieved by providing business and skills development opportunities in the form of infrastructure development projects, further education & training; as well as mentorship to new and existing contractors that are registered on CIDB Grades 1 to 5. It is the intention of the CoE that upon successful completion of the programme, the contractors would be equipped with adequate administrative, technical, contractual, managerial, financial management, and entrepreneurial skills that would enable them to operate sustainable business entities that can compete in the broader construction industry.

Admission into the programme shall enhance the participation of youth, women, persons living with disabilities, and other previously disadvantaged individuals</li> <li>13.
